## Smt. A Satyavathi and Prof. A A N Raju – IASLIC Best Young LIS Teacher Award - 2014 and 2015

IASLIC has instituted a national level **Smt. A Satyavathi and Prof. A A N Raju – IASLIC Best Young LIS Teacher Award** since 2008, sponsored by Prof. A A N Raju.

Six copies of nominations in prescribed format may be sent to the **Honorary General Secretary, IASLIC, P-291, CIT Scheme No. 6M, Kankurgachi, Kolkata - 700054** on or before **15 September 2018**. A valid IASLIC member can recommend a candidate with written consent of the proposed nominee.

Eligibility criteria for the nominees of Smt. A Satyavathi and Prof. A A N Raju – IASLIC Best Young LIS Teacher Award:

- 1. The candidate must be a citizen of India and a member of IASLIC continuously for at least five preceding years to the year of the award.
- 2. The candidate must be within 40 years of age (a valid age proof must be submitted)
- 3. The candidate must be employed in the post of a full-time teacher of Library and Information Science at a UGC recognized Indian University / Deemed University / Institute recognized by the Government of India on permanent and regular basis against a substantive post.
- 4. The candidate must have at least eight years of continuous service in a full time teaching post.
- 5. The candidate must possess a master's degree in Library and information Science or equivalent qualification obtained from a UGC recognized university / deemed university or an institute recognized by the Government of India.
- 6. The candidate must have a good academic record at bachelor's degree level and master's degree level (or at second semester examination and fourth semester examination in case of two-year integrated master's degree course) in library and information science.
- 7. The candidate must be known for his ability as a teacher.
- 8. The candidate should have published, as a single author, at least 5 papers in peer-reviewed journals brought out in the country with ISSN member or abroad.
- 9. The candidate shall be a valid member of at least two registered and recognized professional associations a state level and a national level besides IASLIC.
- 10. A member of the Executive Committee of the IASLIC shall not be eligible for submission of nomination for the award and / or propose or second nomination for any award.
- 11. An awardee of this category shall not be eligible to file his / her nomination for the same award on any subsequent occasion.
- 12. The candidate's nomination has to be proposed by two valid members of IASLIC and also seconded by two other valid members of IASLIC by affixing their signatures on the nomination paper in prescribed format.

## Note:

- If no candidate is found suitable for the award (i.e. score is less than 60%) by majority of adjudicators in a particular year, the award will not be given in that year.
- Nominations for the award will not be considered if at least three nominations are not received in a year and the award will not be given in that year.
