S M Ganguly - IASLIC Award for the Librarian of the Year - 2014 and 2015

IASLIC has instituted a national level **S M Ganguly** – **IASLIC Award for the Librarian of the Year**, sponsored by Late **S M Ganguly**, one of the founder members of IASLIC, since 1993.

Six copies of nominations in prescribed format may be sent to the **Honorary General Secretary, IASLIC, P-291, CIT Scheme No. 6M, Kankurgachi, Kolkata - 700054** on or before **15 September 2018**. A valid IASLIC member can recommend a candidate with written consent of the proposed nominee.

Eligibility criteria for the nominees of the S M Ganguly – IASLIC Award for the Librarian of the Year:

- 1. The candidate must be a citizen of India and a member of IASLIC continuously for at least ten years preceding to the year of the award.
- 2. The candidate must be above 50 years of age (a valid age proof must be submitted).
- 3. The candidate must be employed as a librarian or in an equivalent post in a permanent and regular establishment in a library or information center or the like of an academic institution / research institution / central of state ministry / central or state government department / corporate unit / public library.
- 4. The candidate must have at least fifteen years of service in full-time professional post.
- 5. The candidate must possess a master's degree in Library and Information Science or equivalent qualification obtained from a UGC recognized university / deemed university or an institute recognized by the Government of India and must have a good academic record at bachelor's degree level and master's degree level (or at second semester examination and fourth semester examination in case of two-year integrated master's degree course) in library and information science.
- 6. The candidate should be known for his / her new ideas and innovations and technical / managerial skills in identifying, locating, collecting, organizing, storing and designing information service.
- 7. The candidate must have published at least ten papers pertaining to library and information science, including at least two as the single author, in peer reviewed journals brought out in the country with ISSN member or abroad.
- 8. The candidate must have organized national / international seminars / conferences and /or contributed to national / international seminars / conferences in the form of presentation of at least ten papers and / or editing seminar / conference publications.
- 9. The candidate shall be a valid member of at least two registered and recognized professional associations a state level and a national level besides IASLIC.
- 10. A member of the Executive Committee of the IASLIC shall not be eligible for submission of nomination for the award and / or propose or second nomination for any award.
- 11. An awardee of this category shall not be eligible to file his / her nomination for the same award on any subsequent occasion.
- 12. A candidate's name has to be proposed by two valid members of IASLIC and also seconded by two other valid members of IASLIC by affixing their signatures on the nomination paper in prescribed format.

Note:

- If no candidate is found suitable for the award (i.e. score is less than 60%) by majority of adjudicators in a particular year, the award will not be given in that year.
- Nominations for the award will not be considered if at least three nominations are not received in a year and the award will not be given in that year.
